**Consideration and approval of recommendation to the Board of Trustees to hire**



Harris is placed at number 13, Gerdes is placed at number 14 and Koziel is placed at number 15. A second tie in scores resulted in a two person tie. A two person lottery was held and the outcome resulted in the individuals being placed in the following order. McPherson is placed at number 19 and Schneidernwend is placed at number 20. A motion to approve the newest Firefighter/Paramedic List with the lottery results was made by Commissioner Hanley with a second by Commissioner Skwarczynski. The motion was approved by a 3-0 vote.

**Conditional Offers for Employment**


Chief Yancey was directed to begin the processing of the background investigations on all candidates up to number 5 on the list (Moretti).
