Minutes of the Minooka FPD Board of Trustee Meeting held on January 12, 2021

The meeting was called to order by President Roberts.

A motion by Trustee Clark to approve the December 8, 2020 open board meeting minutes, seconded by Trustee Underhill. All were in favor and the motion carried.

A motion by Trustee Clark to approve the Treasurer's Report, seconded by Trustee Robinson. A roll call vote was taken as follows: Clark-Yes, Robinson-Yes, Roberts-Yes, Underhill-Yes, Baron-Yes, Motion carried.

A motion by Trustee Underhill approving the bills and payroll for December in the amount of \$363,903.28 seconded by Trustee Robinson. A roll call vote was taken as follows: , Underhill-Yes, Robinson-Yes, Clark-Yes, Baron-Yes, Roberts-Yes, motion carried.
