The minutes shall reflect that Trustee Jason Baron was reappointed by Will County as the Will County representative to the Fire District Board of Trustees.

Chief's Report:

- Chief Yancey reported on the following
 - Outlined a plan to surplus vehicles. Discussion was held concerning surplus of 2003 Ford pickup truck (1318) and to utilize the 2007 GMC pickup truck as the utility vehicle and snow plow. Trustees discussed that the chief research surplus of both vehicles and purchase a new replacement. Chief to research and report back at the June meeting.
